The fee for care will be charged **proportionally based on the number of hours used**

- in the **commencement** of care relationship or **during the termination of it in the middle of the month**
- if the place of care is **closed**, and the alternative place of care is not a part of the municipal care
- **during the holidays of early childhood education** (winter holiday, summer, autumn holiday, christmas)
- **during the holidays of preschool education if the child attends early childhood education (higher fee)**

The decision on the fees will mainly be made as permanent until the end of term. If the total number of hours/month is exceeded, the fee will be charged based on the hour intervals for the real **time in care** (=higher %).

**PLEASE REPORT THE RESERVATIONS FOR THE TIME OF CARE TO THE PLACE OF EARLY CHILDHOOD EDUCATION BY MONDAY THE WEEK BEFORE AT 12.00.**

If the need of hours/month **changes**, the **agreement can be amended to meet the need**. An absence similar to holiday is not a reason for a discount. Refunds are not made for short periods, agreement should **last for at least 3 months**. If the period of hours is difficult to choose due to changing required times of care, a monitoring period of 3 months can be used in making of the service agreements.

According to the law, the determined monthly fee is also charged for the period of a child's absence (holiday, illness, or other day of absence).
